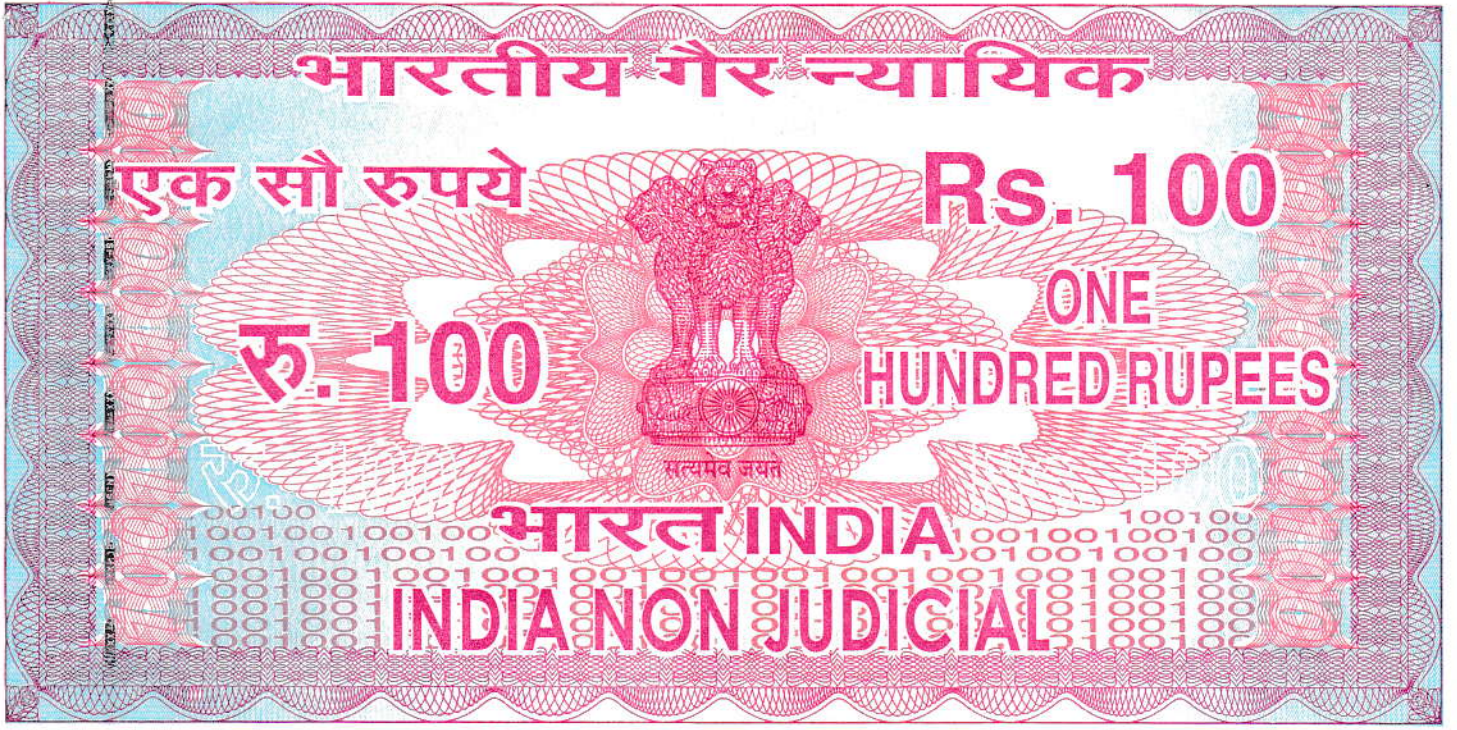

Initially the total number of students placed will be 60 divided into batches and the number may increase in the succeeding years.

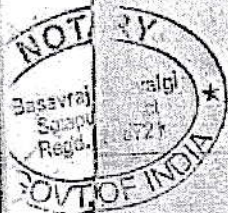

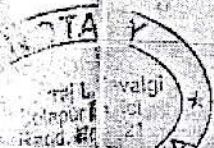

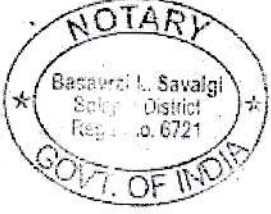

IMPORTANT TERMS AND CONDITIONS

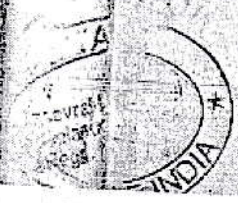
In case party of second part requires to start their own B.Sc. Nursing Course, in that case party of First Part will not take any objection.

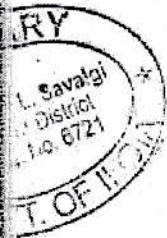

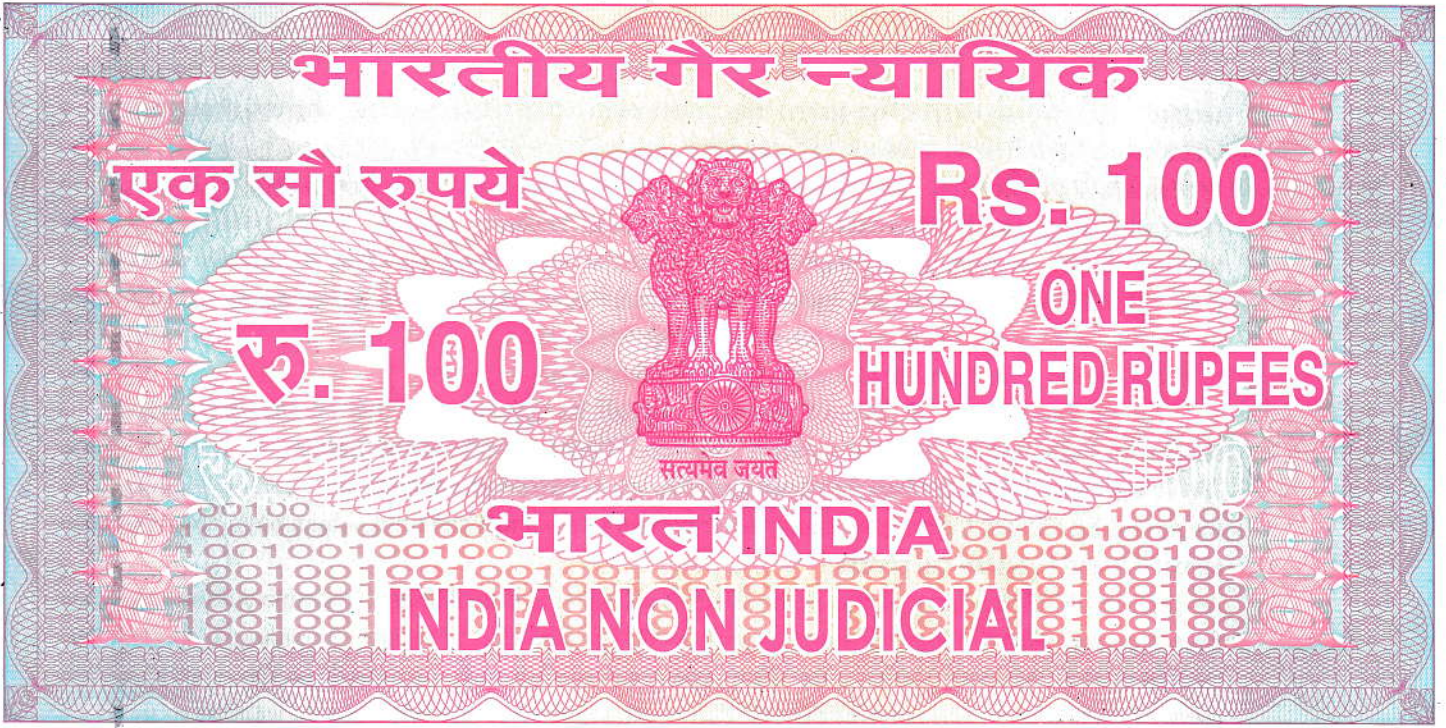
